ORDER

WHEREAS, keeping in view the larger public interest in the scenario of COVID-19, in continuation to earlier order No. 2822 dated 24.02.2021, also keeping in view the latest guidelines of the Department of Home, Government of Punjab (DoH, GoP) issued vide letter No. 7/56/2020/2H4/1024 dated 24.02.2021

2. THEREFORE, I, GirishDayalan, IAS, District Magistrate, in continuation of earlier orders and in exercise of powers conferred under Section 144 of CrPC1973 and National Disaster Management Act 2005, orders as under in the District S.A.S Nagar with immediate effect till further orders:--

1. Night Curfew (11.00 PM to 05.00 AM)

Movement of individuals for all the non essential activities shall remain prohibited between (11.00 PM to 05.00 AM) throughout the District.

However, essential activities including operation of multiple shifts, movement of persons and goods on National and State Highways and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and airplanes will be permitted.

Industries and industrial establishments, construction activities etc. allowed during curfew.

Municipal services are also exempted during the night curfew.

2. Permits and passes:

No separate permission would be required by the industries and other establishments for their operations. All employees would be allowed without any requirement of pass during the night shifts.

- Ceiling of 100 and 200 persons on various indoor and outdoor social/ religious/ sports/ entertainment/ educational/ cultural/ religious gatherings shall be strictly enforced.
 - The Police Authorities/Commissioner, MC/SDMs and all EOs of MC of District S.A.S Nagar shall also continue to ensure strict implementation of all the extant directives of MHA/State Government on Covid appropriate behavior including social distancing norm of minimum 6 feet distance, regulating crowds in markets and public transport and imposition of penalties prescribed for violation of Covid appropriate behavior like wearing of face masks and spitting in public etc.
- Penal provisions: Any violation of these guidelines shall be punishable under sections 51 to 60 of the Disaster Management Act, 2005 besides legal action under section 188 of Indian Penal Code (IPC).



Advisories: The Health & Family Welfare Department, Punjab has issued advisories on different subjects. All concerned shall ensure compliance of these advisories.

Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 and the Indian Penal Code, 1860.
