THE HOUSE OF PARLIAMENT FROM 23-TIRUPATI (SC) PARLIAMENTARY  
CONSTITUENCY.

No.100/AP-HP/1/2021 (1), dated 23<sup>rd</sup> March, 2021 / 2 Chaitra, 1943 (Saka) is re-published:-

### NOTIFICATION

**No.100/AP-HP/1/2021 (1):- WHEREAS**, the seat of Shri Balli Durga Prasad Rao in the House of  
the People, elected from 23-Tirupati (SC) Parliamentary Constituency in the State of Andhra  
Pradesh has become vacant on 16.09.2020 by reason of his demise; and

**WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused;

**NOW, THEREFORE**, in pursuance of sections 149, 30 and 56 of the Representation of  
the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

**(A) calls upon** the said 23-Tirupati (SC) Parliamentary Constituency in the State of Andhra  
Pradesh, to elect, before 4<sup>th</sup> May, 2021 (Tuesday) and in accordance with the provisions of the  
said Act and of the rules and orders made thereunder, a person belonging to any of the Scheduled  
Caste, whether of that State or of any other State, for the purpose of filling the said vacancy in the  
House of the People;

**(B) appoints**, with respect to the said election,-

- (a) the 30<sup>th</sup> March, 2021 (Tuesday), as the last date for making nominations;
- (b) the 31<sup>st</sup> March, 2021 (Wednesday), as the date for scrutiny of nominations;
- (c) the 3<sup>rd</sup> April, 2021 (Saturday), as the last date for the withdrawal of candidatures;
- (d) the 17<sup>th</sup> April, 2021 (Saturday), as the date on which a poll shall, if necessary, be taken;  
and
- (e) the 4<sup>th</sup> May, 2021 (Tuesday), as the date before which the election shall be completed;  
and

**(C) fixes the hours** from 7.00 A.M. to 7.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
