<u>Order</u>

Whereas, the COVID-19 has been declared as pandemic by the World Health Organization and National Disaster Management Authority being satisfied that the whole country including the state of Haryana is threatened with COVID-19 pandemic.

Whereas, it is evident that there has been an exponential surge in the COVID-19 cases in the district Gurugram, and necessary measures are to be adopted to contain the spread of the COVID-19 and also to ensure minimum collateral damage to the

Whereas, in compliance of Government of Haryana, State Disaster system. Management Authority order no. DMC-SPO-2020/18314 dated 24.04.2021 and in exercise of the powers under relevant provisions of the National Disaster Management Act, 2005, I, Deputy Commissioner-cum-Chairperson, District Disaster Management Authority, Gurugram do hereby issue following directions and guidelines for the containment of COVID-19 pandemic in district Gurugram with immediate effect:-

All IT/ ITES units and Corporate offices in the districts Gurugram shall operate their offices through work from home upto 3 May, 2021 at 09:00 AM. 1.

Social/ academic/ sports/ entertainment/ cultural/ religious/ political functions 2. and other congregation

In supersession of Section 5 of this office order no. 1244/MB dated 16.04.2021, Social/ academic/ sports/ entertainment/ cultural/ religious/ political functions and other congregation in the district Gurugram will be allowed in areas outside the Containment zones only, with strict adherence to the appropriate COVID-19 behaviour such as social distancing norms, wearing of face masks, sanitization, hand hygiene and provision for thermal scanning, etc., as follows:-

- i. In indoor spaces, a maximum of 50% of the hall capacity will be allowed with a ceiling of 30 persons. This would also include all Cinemas/ Theaters/ Multiplexes/ Bars/ Hotels/ Clubs/ Gyms. The capacity of indoor places will be specified by the Urban Local Bodies/ Department concerned keeping in mind a calculated correlation between the number of chairs/ seating or standing capacity and the covered area in sq. yards/ sq. feet.
- ii. In open spaces, gatherings will be allowed with the ceiling of 50 persons.
- iii. For Funerals and cremations, participation will be limited to a maximum of 20 persons.

It is further directed that the organizers of Social/ academic/ sports/ entertainment/ cultural/ religious/ political functions and other congregation shall take prior permission of concerned Sub Divisional Magistrate. The concerned Sub Divisional Magistrate will issue permissions after obtaining necessary NOCs from Departments concerned including Police, MCGs, Civil Surgeon.

The public is hereby advised to conduct marriages and other functions during day time only so as to avoid rush/ traffic inconvenience at the time of commencement of 'Corona Curfew'.

Strict enforcement of the orders. 3.

The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/ Police Officials on duty and local bodies in their respective jurisdiction. Any violation of the same shall be strictly dealt with as per the provisions of Section 51 to 60 of the National Disaster Management Act, 2005, besides legal action under Sec. 188 of the IPC and other legal provisions as applicable.

It shall be published for the information of public in general through the press and publicity Van of public relations department and by affixing copies at notice board of all Offices of the district administration, Commissioner of Police, District Court, Deputy Commissioner, Commissioner Municipal Corporation, Sub Divisional Magistrate, Tehsil, Zila Parishad, Panchayat Samiti, Police Station and other prominent places.
