came. Periodic instructions from the Central Government and the State Government in this regard  
as well**

**Guidelines have been issued. Ministry of Home Affairs, Government of India  
Order No: 40-3 / 2020-DM-1 (A) dated 29.04.2021 to prevent corona transition  
Advanced instructions are provided.**

**Housing by the State Government in view of the transition of coVID-19 in the State  
Order No: V-1 / KA / 102050/2-B of the department dated 27.05.2021**

**Some restrictions have been put in place across the state.**

**3. Reviewing the current situation in the state**

**Department of the Interior**

**Dt. Order No. of 2021: V-1 / KAV / 102050/2-B in the entire state**

**The period of the following controls implemented is dated 20.05.2021**

**Total from 09:00 in the morning till 06:00 in the morning on 04.06.2021**

**The period is extended.**

**A. Weekly Gujri / Bazaar / Hat, Educational Institution and Coaching Centers (Online Education  
Except), Cinema Theaters, Auditorium, Assembly Hall, Water Park, Public Garden-  
Gardens, recreational areas, gym, spa, swimming pool will be closed.**

**B. A maximum of 50 (fifty) open or closed places for marriage during this period.  
Individuals will be allowed. Registration for marriage on DIGITAL GUJARAT PORTAL  
The provision remains unchanged.**

**C. A maximum of 20 (twenty) persons will be allowed for funeral / burial.**

**D. Government, Semi-Government, Board, Corporation, Bank, Finance Tech related services, Cash  
Transaction Services, Banking Clearing House, ATM / CDM Repairers, stock  
In exchanges, stock brokers, insurance companies and all kinds of private offices  
The attendance of employees should be ensured up to 50%. Essential services  
This provision will not apply.**

**E. All kinds of political, social, religious, cultural, educational programs / gatherings  
Will be completely closed.**

**F. Sports in a sports complex / sports stadium / complex without the presence of spectators  
Can be continued.**

**G. All places of worship will be closed to the public. Daily at shrines  
Worship / ritual should be performed only by the administrators / priests of religious places.  
Public bus transport will continue at a maximum of 50% passenger capacity.**

- . Health related to RTPCR Test to passengers entering Gujarat from other states  
And the instructions given by the Family Welfare Department will apply.**
- . All must strictly adhere to face cover, mask and social distance.**

**All Police Commissioners / District Magistrates have this in their jurisdiction  
Cr.P.C. for the execution of the order. And out of the notification under the provision of Gujarat  
Police Act  
Will have to provide.**

- . Effective implementation of this order Survey Police Commissioner, District Magistrate and  
District**

**Will have to be done by the police chief.**

- . Violation of this Order under "THE EPIDEMIC DISEASES ACT 1897"**

**GUJARAT EPIDEMIC DISEASES COVID-19 REGULATION, 2020'**  
**Provisions, Section 188 of "THE INDIAN PENAL CODE" and "THE DISASTER"**
