Therefore, as per the order in the above reference no.

Therefore, in order to curb the spread of Covid 19 disease in the state, the government has issued revised orders to effectively break the restrictions on transmission chain wise district / administrative unit wise and to start various economic and social activities in a planned manner.

Under this Act, Covid 19 Measures Scheme Rules 2020 have been implemented in the state due to Corona Virus. Covid 19 average positive door in Pune Municipal Corporation area is 6. I am issuing the following amended order to prevent the spread of Covid 19 in the area of Vikram Kumar, Commissioner Pune Municipal Corporation, Pune Municipal Corporation as per the authority vested in me under the Infectious Diseases Act, 1897 and Disaster Management Act, 2005.

Essential Services This will include the following services

- Hospitals, diagnostic centers, clinics, vaccinations, medical insurance Offices, pharmacies and pharmaceutical companies, other medical and health services, it Auxiliary manufacturing and distribution units, as well as their dealers, transport and supply establishments, vaccines, sanitizers, masks, medical supplies and equipment, clad goods manufacturing and supply and all related services.
- Veterinary Dispensaries, Pet Care Centers, Pet Food Shops
- Works related to afforestation as declared by the Forest Department
- Airlines and related services
- Grocery, vegetable, fruit seller, dairy, bakery, confectionery and all kinds
- Food shops, shops selling mutton, chicken, eggs, fish
- Cold storage and warehouse services

- Public transport taxis, rickshaws, trains, airlines, public buses
- > Offices of ambassadors of different countries
- > Pre-monsoon planned works
- Public services provided by local authorities
- > Services provided by the Reserve Bank of India and their essential services
- ➤ SEBI as well as SEBI offices and related service providers (Stock

Exchange, Depositories and Clearing Corporation and intermediaries

Registered with SEBI)

- > Telecommunication services and related maintenance and repair services
- > Freight
- Water supply services
- Agricultural related services and related establishments (seeds, fertilizer equipment and Maintenance and repair services related to them etc.)
- ➤ All types of import-export
- ➤ E-Commerce (for the supply of essential goods and services)
- Accredited media
- Services providing petrol pumps and petroleum related products (including offshore/onshore production)
- ➤ All types of cargo / courier services
- Infrastructure related to data center / cloud services / information and technology and service
- Public and private security services
- Electricity and gas distribution services

- ➤ ATM's
- Postal service
- Ports and related activities
- Official licensed multimodal transport operator dealing with custom house agents, vaccines / drugs / lifesaving drugs.
- Services that manufacture / supply raw materials, packaging materials for any essential services
- > Services that produce materials for citizens or organizations for the rainy season
- Essential services declared by the Disaster Management Authority.
- 2) Establishments / services being exempted
- A) Offices -

The following offices in the Pune Municipal Corporation area will continue.

- Offices of Central, State, Local Self Government Institutions
- > Co-operative Banks, Public Sector Banks, Private Banks
- Offices of companies providing essential services
- Insurance / Mediclaim Company
- Pharmaceutical establishments and equipment manufacturers As well as the offices associated with it
- Institutions under the control of the Reserve Bank, payment system operators and markets regulated by the Reserve Bank Components and intermediaries with financial market participants working in the sector)
- ➤ All non-banking financial corporations
- > All micro finance institutions
- Offices of Advocates, CAs, Offices related to Financial Institutions

- 3) The shops mentioned in all the essential services in Pune Municipal Corporation area will be open all the days of the week till 04.00 pm.
- 4) Apart from essential shops, other shops will be open from Monday to Friday from 04.00 pm. Weekends will be completely closed.
- 5) Malls, cinemas, theaters will be completely closed.
- 6) Restaurants, bars, food courts will be open from Monday to Friday at 4.00 pm with 50% seating capacity. After 4.00 pm and on weekends only parcel service / home delivery service will continue till 11.00 pm.
- 7) From local train only for medical service, essential service staff and women, government Employees of staff, airport services, port services will be allowed to travel.
- 8) Public places (parks), open ground, walking and cycling in Pune Municipal Corporation area
- All days of the week will be open from 05.00 am to 09.00 am.
- 9) Except for the established establishment / service, all private offices will be open till 4.00 pm on working day with 50% staff capacity.
- 10) All the essential services in the Pune Municipal Corporation area and government offices related to the management of Kovid-19 will continue at 100% capacity.

Government offices (excluding essential / corona related offices) will continue to be in attendance of 50% officers / staff. If the above offices / establishments are required to have more staff than this, the head of the concerned establishment should seek the permission of the Disaster Management Authority.

- 11) All outdoor sports will be open all day from 05.00 to 09.00 in the morning.
- 12) Social, religious and entertainment programs in the presence of 50 people from Somtar to Permission will be available till 04.00 pm on Friday.
- 13) Wedding ceremonies will be allowed in the presence of a maximum of 50 people.
- 14) Funerals, Dashakriya and related programs in the presence of maximum 20 people Will be allowed to.
- 15) Main meetings of various meetings, meetings, local organizations and Satfari organizations. Elections will be allowed in 50% turnout.

- 16) In the construction area of Pune Municipal Corporation where the workers can stay, the construction can be continued. However, if there are foreign workers, such construction will be allowed to continue till 04.00 pm. However, the employees coming from outside will leave at 04.00 pm to go home.
- 17) Agriculture related shops and related establishments (B-seeds, fertilizers, equipment and related maintenance and repair services etc.) as well as shops / stalls selling agricultural produce in the Agricultural Produce Market Committee will be open all the days of the week till 04.00 pm.
- 18) E-commerce services will be allowed to supply all goods and services.
- 19) In the area of Pune Municipal Corporation, it will be prohibited to gather more than 5 people (curfew) till 05.00 pm and section 144 (curfew) is being implemented after 05.00 pm.
- 20) Gymnasiums, salons, beauty parlors, spas, wellness centers with 50% seating capacity will be open till 04.00 pm as per pre-arranged time. However, air conditioning facility cannot be used in this place.
- 21) Public transport system in Pune Municipal Corporation area will be started with 50% of seating capacity.
- 22) Vehicles carrying goods and a maximum of 3 persons (driver + cleaner / helper) will be allowed to travel in accordance with the rules applicable to other passengers.
- 23) It will be allowed to travel in the district by private vehicle, buses and long distance train. However, if these vehicles will stop at level 5 declared by the government, then it will be mandatory to have E-pass. In this case, a separate E-pass will be required for each person traveling in the vehicle.
- 24) Production in Export Oriented Units (Including MSME's that need to be fulfilled export obligation) will continue on a regular basis.
- 25) The following manufacturing areas / industries will continue regularly.
- A) Industries producing essential commodities (Including ware manufacturing units, packaging units and the entire supply chain required by industries that produce essential goods).
- B) Continuous Processing Industries (Units that require process that are of such a nature that these cannot be stopped immediately and cannot restart without considerable time requirement)
- C) Manufacturing industries related to national security and defense. (Manufacturing of items that are significant to National Security and Defense)

- E) Data Centers / Cloud Service providers / IT Services supporting critical infrastructure and services
- 26) Except for the industries mentioned in the above issues No. 24 and 25, all other manufacturing sectors will continue with 50% staff capacity. The concerned industries should make separate transport arrangements for the transportation of employees. These employees will not be able to travel on public transport.
- 27) Employees working in the establishments permitted in the above order which will continue till 04.00 pm as well as the citizens receiving services from that place are expected to reach their homes by 05.00 pm.
- 28) Regular classes of all primary, secondary schools, colleges, educational institutions in the Pune Municipal Corporation area will be completely closed till June 30, 2021. However, online education will be allowed. All types of coaching classes will be completely closed.
- 29) Liquor shops will be open from Monday to Friday at 04.00 hrs. Weekend -Home delivery facility will continue.
- 30) This order will also be applicable to Pune Cuttack Mandal and Khadki Cuttack Mandal coming under Pune Municipal Corporation area.
- 31) The orders / guidelines issued from time to time as per the reference orders will be applicable till the next order.
- 39) These orders have been issued keeping in view the level fixed by the Government as per the average positivity rate and percentage of oxygen bed occupancy in the Pune Municipal Corporation area. If any increase / decrease is found in it, a revised order is issued after reviewing it

 Will be done.

Any person violating the orders and guidelines issued by this office from time to time for the prevention of COVID-19 shall be prosecuted under Sections 51 to 60 of the Disaster Management Act, 2005 and other legal provisions as per Section 188 of the Indian Penal Code.

These orders will be applicable in the jurisdiction of Pune Municipal Corporation from 07.06.2021 till further orders.
