## **ORDER**

## Sub.:- Increase in the Special Allowance/Dearness Allowance & H.R.A. w.e.f. 1st July 2021.

The Board had revised the Special Allowance/Dearness Allowance & H.R.A of the registered Security Guards/ Officers vide this Office Order No. SGB/Raigad/2021 Dt. 06.08.2021.

The Competent Authority, Under The Minimum Wages Act 1948, Mumbai. vide its Order No. RW/MWA/DA/2021-2/Desk-10/6509 Dt. 04.08.2021 declared the rates of Special Allowance/Dearness Allowance for the period from 1st July 2021 to 31st December 2021. On dated 11.06.2019 this Board has fixed the rate of wages payable to Security Guard/Officers in accordance with Special Allowance for shop and Establishment of minimum wages Act, 1948. Hence this the board has decided to revise the Special Allowance/Dearness Allowance and House Rent Allowance payable to the Registered Security Guards/Officers of the Board for the period from 1st July 2021 to 31st December 2021. Accordingly the rate of Special Allowance/Dearness Allowance of the Security Guard/Officer is Rs.1430.00 p.m.

House Rent Allowance @ 20% on Minimum Wages (Wages & Special Allowance/Dearness Allowance) is also made applicable to the Security Guard/Officer for the period 1st July 2021 to 31st December 2021. The rate of Basic Wages, Conveyance Allowance, Washing Allowance, Leave Time Conveyance Allowance & Education Allowance are remain same as per the Order.

Basic Pay + Special Allowance/Dearness Allowance = Minimum Wages

It is obligatory on the part of the registered Principal Employer to pay 42.75% levy on the Minimum Wages i.e. the amount of Basic Wages + Special Allowance/Dearness Allowance. The Principal Employer is also required to pay 3.25% levy on House Rent Allowance, Conveyance Allowance, Education Allowance, Leave Time Conveyance Allowance & Over Time Wages.

Over Time Wages should be calculated at double the normal rate, on Minimum Wages (i.e. Basic Wages + Special Allowance/Dearness Allowance)

All Registered Principal Employers hereby directed to remit the Wages, Allowance & Levy thereon at revised rates w.e.f. 1st July 2021 in respect of registered Security Guards allotted to them.
