- 2. Restaurants with a maximum capacity of 5% seating capacity until 12:00 pm Will be able to continue subject to the prescribed 6.0.P. as long as the guideline is followed. Home Delivery And take away can also be continued till 12:00 pm.
- 3. Cinema hall can be maintained with 100% capacity.
- 4. New Year's Eve Sneha Milan Events Conditioned as per Corona Guideline Subject to S.O.P., maximum 500 persons in open but in closed places, 50% of space capacity (Up to a maximum of 200 persons).
- 5. Subject to Corona's guideline subject to prescribed 6.0.P., maximum 500 in open.Sixth puja religious programs can be organized within the limits of individuals.
- 6. Spa Centers with strict adherence to the prescribed Corona Guidelines from 09:00 AM to 08:00 PM Can be continued for hours. With the owners, administrators, staff as well as operations of the spa center The first dose of vaccine will be mandatory for all those involved. RTPCR test of individuals. In case of positive RTPCR test from 15 days after coming positive / The first of the vaccine immediately after completion of 30 days from the date of hospital discharge summary. The dose will have to be taken. The second dose is also taken if the prescribed time limit has been met by taking the first dose It should be.
