Sub: Rural Local Body Elections 2021 to be held on 6<sup>th</sup> October, 2021 and 9<sup>th</sup> October, 2021 – Declaration of public holidays with wages to the labourers on the date of polling – Requested.

2. From the Chief Secretary to Government, Letter No.19071/PR.1(1)/2021-2, Rural Development and Panchayat Raj Department, dated 28.09.2021.

I am directed to enclose a copy of the reference cited together with its enclosure and to state that the Tamil Nadu State Election Commission has notified the schedule for the Ordinary Elections / Casual Elections to Rural Local Bodies, 2021. The 1<sup>st</sup> phase of Ordinary Election is on Wednesday, the 6<sup>th</sup> October, 2021 and the 2<sup>nd</sup> phase of Ordinary Election is on Saturday, the 9<sup>th</sup> October, 2021 to the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi. Casual Elections in other 28 Districts is on Saturday, the 9<sup>th</sup> October, 2021 in single phase.

- Based on the statutory provisions in Section 80-A of the Tamil Nadu Panchayat Act, 1994 (Tamil Nadu Act 21/1994), every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at Ordinary Elections on 6.10.2021 in the areas where polling takes place in the first phase and on 09.10.2021 in the areas where polling takes place in the second phase in the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi and at Causal Elections on 09.10.2021 in the areas where polling takes place in the single phase in other 28 Districts shall be granted as public holidays, and no deduction or abatement of the wages of any such person shall be made on account of a holiday having been so granted. If an employer contravenes these statutory obligations, then such employer shall be punishable with fine which may extend upto five hundred rupees.
- 3. I am therefore to request you to issue necessary instructions to the concerned authorities on the above lines to the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi and also Causal Elections to be held in other 28 Districts. A copy of the instructions issued in this regard may be sent to the Government for information and record.

I am directed to state that the Tamil Nadu State Election Commission has notified the schedule for the Ordinary Elections/Casual Elections to Rural Local Bodies, 2021. The 1st phase of Ordinary Election is on Wednesday, the 6th October, 2021 and the 2<sup>nd</sup> phase of Ordinary Election is on Saturday, the 9<sup>th</sup> October, 2021 to the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi. Casual Elections in other 28 Districts is on Saturday, the 9<sup>th</sup> October, 2021 in single phase.

- 2. In this connection, I am directed to state that, section 80-A of the Tamil Nadu Panchayat Acts, 1994 provides as follows:
  - "(1) Every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at election to any Panchayat shall on the day of poll, be granted a holiday.

- (2) No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with sub-section (1) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have drawn had not a holiday been granted to him on that day.
- (3) If an employer contravenes the provisions of sub-section (1) or sub-section (2), then such employer shall be punishable with fine which may extend to five hundred rupees.
- (4) This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."
- 3. In the Government Order second cited (copy enclosed), the Government have declared, in respect of Ordinary Elections to the Rural Local Bodies in nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi, the dates of poll on 06.10.2021 in the areas where polling takes place in the first phase and on 09.10.2021 in the areas where polling takes place in the second phase as public holidays and in respect of Casual Elections to the Rural Local Bodies in other 28 Districts, the dates of poll on 09.10.2021 in the areas where polling takes place in the single phase as public holidays, under section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881)
- 4. I am, therefore, to request you to bring the above said legal provisions and also the Government Order second cited to the notice of all Industrial Establishments through the Commissioner of Labour and Employment to provide holiday with wages on the date of poll in the respective areas to the labourers working in public and private sector establishments in the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi and Casual Elections to be held in other 28 Districts.

I am directed to state that the Tamil Nadu State Election Commission has notified the schedule for the Ordinary Elections/Casual Elections to Rural Local Bodies, 2021. The 1<sup>st</sup> phase of Ordinary Election is on Wednesday, the 6<sup>th</sup> October, 2021 and the 2<sup>nd</sup> phase of Ordinary Election is on Saturday, the 9<sup>th</sup> October, 2021 to the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi. Casual Elections in other 28 Districts is on Saturday, the 9<sup>th</sup> October, 2021 in single phase.

- 2. Section 80-A of the Tamil Nadu Panchayat Act, 1994 (Tamil Nadu Act 21/1994) pertaining to grant of paid holiday to employees on the day of poll is extracted below:
  - "(1) Every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at election to any Panchayat shall on the day of poll, be granted a holiday.

(P.T.O)

- (2) No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with sub-section (1) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless been granted to him on that day.
- (3)\*If an employer contravenes the provisions of sub-section (1) or sub-section (2), then such employer shall be punishable with fine which may extend to five hundred rupees.
- (4) This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."
- 3. Based on the above said statutory provisions, I am to inform you that every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at ordinary election on 06.10.2021 in the areas where polling takes place in the first phase and on 09.10.2021 in the areas where polling takes place in the second phase in the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, polling takes place in the single phase in other 28 Districts shall be granted as public made on account of a holiday having been so granted. If an employer contravenes may extend upto five hundred rupees.
- 4. I am, therefore, to request you to issue necessary instructions to the concerned authorities on the above lines to the nine newly re-constituted Districts viz., Kancheepuram, Chengalpattu, Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi and also Casual Elections to be held in other 28 Districts and send a copy of the same to this department immediately.

#### ORDER:

The Tamil Nadu State Election Commission has notified the schedule for the Ordinary Elections to Rural Local Bodies in nine re-constituted districts in two phases. The 1<sup>st</sup> phase of election is on Wednesday, the 06<sup>th</sup> October, 2021 and the 2<sup>nd</sup> phase of election is on Saturday, the 09<sup>th</sup> October, 2021. The Casual Elections to Rural Local Bodies in the other 28 districts in a single phase on the 09<sup>th</sup> October, 2021.

- 2. Therefore, the Government have decided to declare the said days of Poll as public holidays under section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881). All Government Offices including industrial establishments of the Government and Government controlled bodies and all educational institutions will remain closed on 06.10.2021 in the areas where polling takes place in the first phase and on 09.10.2021 in the areas where polling takes place in the second phase and Casual Elections in the other 28 districts.
- 3. Accordingly, the following Notification will be published in an Extraordinary issue of the <u>Tamil Nadu Government Gazette</u>, dated the 28<sup>th</sup> September, 2021.

#### NOTIFICATION

Under the Explanation to section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881) read with the Notification of the Government of India, Ministry of Home Affairs No.20-25-26, Public-I, dated the 8<sup>th</sup> June 1957, the Governor of Tamil Nadu, hereby declares Wednesday, the 06<sup>th</sup> October, 2021 and Saturday, the 09<sup>th</sup> October, 2021 the dates on which the poll for the Ordinary elections to the rural local bodies 2021 will take place, to be public holidays, in those areas wherever such poll takes place in the nine re-constituted districts, namely Kancheepuram, Chengalpattu,

Vellore, Ranipet, Tirupathur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi and also declares Saturday, the 9th October, 2021, the date on which the poll for the Casual elections to the Rural Local Bodies will take place, to be a public holiday, in those areas wherever such poll takes place in the other 28 districts.
