In compliance of the directions of W/Adviser to the Administrator, UT, Chandigarh vide orders bearing No. 13180-HIII(5)-2021/19029 dt. 24.12.2021 and subsequent orders bearing No. 13180-HIII(5)-2021/19108 dt. 27.12.2021 and meeting held on 28.12.2021 under the Chairmanship of W/Deputy Commissioner, UT, Chandigarh.

In order to ensure the safety of public and prevent the third wave of COVID-19 pandemic, strict adherence to the guidelines enshrined in the said orders are of utmost importance. In furtherance of these orders, it has been decided that in shops, malls, commercial establishments, factories & companies, the owner/occupier/manager of the establishment concerned shall be held liable in case any employee or visitor are found violating the said guidelines viz. only fully vaccinated (2nd dose) adult persons with proper mask are allowed inside their premises.

The following staff/officials of the Labour Department, UT, Chandigarh and its allied boards are hereby directed to ensure the strict enforcement of the said orders w.r.t. shops, malls, commercial establishments, factories and companies situated in the jurisdiction against their names and ensure that only fully vaccinated (2nd dose) adult persons with proper mask visit such premises.
