
ORDER

**Subject:** Timing of opening/closing of the shops as per section 15 of Delhi Shops & Establishment Act, 1954.

This is with reference to subject mentioned above. It has come to notice that many Shops are open beyond the closing hours i.e. 11 PM as prescribed under section 15 of Delhi Shops & Establishments Act, 1954, without taking exemption from competent authority, which is violation of section 15 of the said Act.

All District In-charges are hereby directed to inspect such shops which are open beyond the closing hours i.e. 11 PM in violation of the section 15 of Delhi Shops & Establishment Act, 1954. In case of finding any violation, the concerned JLC/DLC shall issue notice to the proprietor/partner/manager of the shop directing not to open the shop beyond 11 PM without getting exemption under section 15 of Delhi Shops and Establishment Act, 1954, with copy endorsed to the concerned SHO with request to ensure that shop is closed by 11 PM every day. The copy of notice shall also be sent to the concerned DCP, Police and Chief Inspector of Shops. The district JLC/DLCs shall also submit report of the action taken on fortnightly basis.
