I am to enclose herewith copy of letter No.78/EPS/2022 dtd.10.05.2022 received from Election Commission of India and say that the Election Commission of India has notified the poll schedule for Bye-Election to 6-Brajarajnagar Assembly Constituency on **31.05.2022**. To facilitate the voters in these areas to exercise their franchise, the Election Commission of India has recommended that every person employed in any business, trade, industrial undertakings or any other establishment and entitled to vote at election to the Legislative Assembly Constituency shall be granted paid holiday on the date of poll.

All business, trade, industrial undertakings and establishments are hereby instructed to grant paid holiday to those employees who will exercise their franchise at 6-Brajarajnagar Assembly Constituency on **31.05.2022**. Any violation to the above instruction will be treated as an offence. The written application by the employees will be sufficient to show their enrolment in the particular Assembly Constituency.


