No. F.W./Election-2022 <sup>19470</sup> Whereas the Bye General Election for which poll shall be held on the 24.06.2022 (Friday) as per letter of the State Election Commission, Haryana issued vide No. SEC/1ME/2022/5988 dated 22.06.2022.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt only those workers who are working in the Factories in the State of Haryana and are enrolled as the voters in Ward No. 08 (booth numbers 13 & 14) of Municipal Committee, Safidon, Jind Void where General Election are to be held on 24.06.2022 (Friday), from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 26.06.2022 and ending on 02.07.2022, subject to the condition that no adult worker who is enrolled as voter for General Election of Ward No. 08 (booth numbers 13 & 14) of Municipal Committee, Safidon, Jind shall be required or allowed to work on 24.06.2022(Friday) in the factories of the state of Haryana.
