It is with reference to the notification no. GAD-A(B) 8-1/2024 dated 21.06.2024 (copy enclosed) vide which special paid holiday has been declared on account of Bye-election to 10-Dehra, 38-Hamirpur & 51-Nalagarh Assembly Constituencies of Himachal Pradesh scheduled to be held on 10<sup>th</sup> July, 2024 (Wednesday).

In this regard, your attention is drawn to the provision of Section 135-B of Representation of the People Act, 1951. For your ready reference the provision of Section 135-B, is as under:-

## "135-B Grant of paid holiday to employees on the day of poll

in any business, trade, Industrial employed 1. Every person or any other establishment and entitled to vote at an election to the House of the People or the Legislative State shall, on the day of poll, be granted a Assembly of holiday.

2. No deduction or abatement of the wages of any such person shall be made on account of holiday having being granted in accordance with sub section (I) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have drawn had not a holiday been granted to him on that day.

3. If an employer contravenes the provisions of sub section (I) or sub section (2), then such employer shall be punishable with fine

which may extend to five Hundred Rupees.

4. This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."

Further, there shall be a special paid holiday on 10<sup>th</sup> July 2024, which is poll day for the registered voters of Punjab State working in the border areas of Una, Kangra, Chamba and Solan, Districts of Himachal Pradesh, on account of bye-election to Assembly Constituency (34-Jalandhar West-SC) Punjab.

Further, there shall be a special paid holiday on 10<sup>th</sup> July, 2024, which is poll day for the registered voters of Uttrakhand State working in the border areas of Sirmour & Shimla Districts of Himachal Pradesh, on account of bye-election to Assembly Constituency (04-Badrinath & Manglaur) Uttrakhand.

are, therefore, directed to bring said the of occupiers/managers notice of to the provisions other commercial factories/Industrial establishments/ shops and establishments situated under said constituencies and direct them to grant special paid holiday to the employees workers working in their factories/ industrial establishments/ shops and other commercial establishments on 10.07.2024 (Wednesday), in order to exercise their right of franchise in bye-elections of Assembly Constituencies where bye-election are scheduled to be held.

It is also clarified that special paid holiday may be given to those employees who are working in different places in the State but have a right to vote in bye-elections of above mentioned Assembly Constituencies on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote.

Special Paid Holiday will be applicable to all Government/ Semi Government employees and to the employees working in Industrial Establishments who are registered voters in above mentioned States/UT.

The above holiday will also be a Special paid holiday under Section 25 of Negotiable Instruments Act, 1881.

It is, however clarified that Special Casual Leave may be given to those employees who are working in different places in the State but have right to vote in other constituencies/places in the Pradesh on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote. It is further clarified that above paid holiday's may be given to such employees, only on the production of certificate of the concerned Presiding Officer that the employee has actually cast his/her vote.
