Whereas the Bye-election to 16-Meerapur AC, 29-Kundarki AC, 56-Ghaziabad AC, 71-Khair (SC) AC, 110-Karhal AC, 213 Sishamau AC, 256-Phulpur AC, 277-Katehari AC and 397-Majhawan AC of Uttar Pradesh State Legislative Assembly is scheduled to be held on 13.11.2024 (Wednesday) as per Chief Electoral Officer, Haryana letter No. 130/Paid Holiday/UP, Bye-Elec-2024/2AE-12516 dated 28.10.2024.

And whereas, it is considered necessary to provide opportunity to those who are working in the State of Haryana/ Chandigarh and enrolled as voter in 16-Meerapur AC, 29-Kundarki AC, 56-Ghaziabad AC, 71-Khair (SC) AC, 110-Karhal AC, 213 Sishamau AC, 256-Phulpur AC, 277-Katehari AC and 397-Majhawan AC of Uttar Pradesh State Legislative Assembly to exercise their franchise.

Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes the 13.11.2024 "Wednesday" to be the holiday with wages for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana, only for their employees who are enrolled as voters in the 16-Meerapur AC, 29-Kundarki AC, 56-Ghaziabad AC, 71-Khair (SC) AC, 110-Karhal AC, 213 Sishamau AC, 256-Phulpur AC, 277-Katehari AC and 397-Majhawan AC of Uttar Pradesh State Legislative Assembly to enable them to exercise their franchise.


