ORDER:

The Election Commission of India has notified 05.02.2025 (Wednesday) as the poll day for the Bye-Election to Tamil Nadu Legislative Assembly from 98. Erode (East) Assembly Constituency, Erode District. Hence, the poll day 05.02.2025 (Wednesday) has to be declared as public holiday under section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881).

2. The following Notification shall be published in an extra-ordinary issue of the Tamil Nadu Government Gazette dated: 20.01.2025.

Notification

Under the "Explanation" to Section 25 of the Negotiable Instruments Act, 1881 (Central Act, XXVI of 1881) read with the Notification of the Government of India, Ministry of Home Affairs No. 20-25-26, Public-1, dated the 8th June 1957, the Governor of Tamil Nadu hereby declares Wednesday, the 05th February 2025, the date on which the poll for the Bye-Election to Tamil Nadu Legislative Assembly from 98. Erode (East) Assembly Constituency will take place, in the areas comprised in the above said Assembly Constituency lying in Erode, to be a Public Holiday.
