NOTIFICATION

In exercise of the powers conferred under sub-section (2) of Section 3 of the Telangana Factories and Establishments (National, Festival and Other Holidays) Act, 1974 (Act No.32/1974) and sub-section (2) of section 31 of the Telangana Shops & Establishments Act, 1988 (Act No.20/1988) read with the provisions laid down in Section 135-B of the Representation of People Act, 1951, Government of Telangana hereby declares public holiday in the area of 61-Jubilee Hills Assembly Constituency of Hyderabad District on the day of poll i.e., **11.11.2025 (Tuesday)** as the case may be, if there is no public holiday, so as to enable the workers and employees to exercise their franchise. Regarding the Industrial Undertakings / Establishments which are working on shift basis, it has been clarified that a holiday is declared only for the shift during which the poll is to be taken.

2. The Commissioner of Labour, Telangana, Hyderabad and the Director of Factories, Telangana, Hyderabad shall take further necessary action, accordingly.
