No. HLWB/REV/2026/ 3436

Dated: 08/05/2026

As per Haryana Government Notification No. 12/LA/2019/16/3917 dated 22.02.2019, compliance was being ensured w.e.f. 01.01.2025 as under:

“(1) Each employee shall contribute to the Fund every month an amount equal to zero point two percent of his salary or wages or any remuneration subject to a limit of rupees thirty-four and each employer in respect of each such employee shall contribute to the Fund every month, twice the amount contributed by such employee.

Provided that the limit specified above shall be indexed annually to the consumer price index beginning from first of January each year.”

अर्थात्

“(1) प्रत्येक कर्मचारी चौतीस रूपए की सीमा के अध्यक्षीन प्रत्येक मास अपने वेतन या मजदूरी या किसी पारिश्रमिक के 0.2 प्रतिशत के बराबर राशि का निधि में अंशदान करेगा तथा प्रत्येक ऐसे कर्मचारी के सम्बन्ध में नियोक्ता, प्रतिमास ऐसे कर्मचारी द्वारा अंशदान की गई राशि का दो दुगना निधि में अंशदान करेगा।

परन्तु उपरोक्त विनिर्दिष्ट सीमा को प्रत्येक वर्ष प्रथम जनवरी से प्रारम्भ होने वाले उपभोक्ता मूल्य सूचकांक से प्रति वर्ष अनुक्रमित किया जाएगा।”

Further, w.e.f. 01.01.2026, the compliance shall be ensured as under:

“(1) Each employee shall contribute to the Fund every month an amount equal to zero point two percent of his salary or wages or any remuneration subject to a limit of rupees thirty-five and each employer in respect of each such employee shall contribute to the Fund every month, twice the amount contributed by such employee.

Provided that the limit specified above shall be indexed annually to the consumer price index beginning from first of January each year.”

अर्थात्

“(1) प्रत्येक कर्मचारी पैंतीस रूपए की सीमा के अध्यक्षीन प्रत्येक मास अपने वेतन या मजदूरी या किसी पारिश्रमिक के 0.2 प्रतिशत के बराबर राशि का निधि में अंशदान करेगा तथा प्रत्येक ऐसे कर्मचारी के सम्बन्ध में नियोक्ता, प्रतिमास ऐसे कर्मचारी द्वारा अंशदान की गई राशि का दो दुगना निधि में अंशदान करेगा।

परन्तु उपरोक्त विनिर्दिष्ट सीमा को प्रत्येक वर्ष प्रथम जनवरी से प्रारम्भ होने वाले उपभोक्ता मूल्य सूचकांक से प्रति वर्ष अनुक्रमित किया जाएगा।”


